

### From Rev. Kim Plumpton

Dear Friends,

While we were dressing the Church ready for Christmas, I darted off to Squires, a garden centre just off the Stoke Road, to see if I could get some soft white lights to match those already in the Church. Of course the garden centre stock was a little limited, and it became apparent that the lights I had hoped to come back with were not available. As I doublechecked the shelves, a lady joined me as she too was looking for lights. It wasn't long before we were enjoying a conversation about lights, Christmas, Church and family. In what seemed like about 15 minutes, we shared our experiences, not on a superficial level but quite deeply, and I was blessed by her openness, her honesty and her warmth. Interestingly I hadn't gone in with my clerical collar on, which can of course work two ways. Some people will open up more and others will do anything to avoid you. But by the time we came to the end of the conversation she wanted the details of the Churches in the pastorate. Funnily enough even though I returned to the Church empty handed, I wasn't disappointed but felt uplifted and grateful for what seemed like a God ordained encounter with this lovely lady at Squires.

After being back at the Church for about twenty minutes another lady appeared in the vestibule. This time a conversation was almost impossible as she was Mexican and spoke very little English. Amazingly only the night before, at a small party at Rhonda's, I met a lady who was also Mexican (who would believe it!) and I knew that if I contacted her she would be able to communicate with this lady. After some hasty phone calls we managed to begin a telephone conversation, as I asked questions and it was translated into Spanish and vice versa. We began to learn a little bit more about one another. I was delighted when she returned the following day at the Carol Service where she received a very warm welcome, even being invited to share Christmas dinner with a Church family. It felt to me by the end of that Saturday morning that God had been very much present in these encounters, knitting together all the pieces without me even being remotely aware of it.

As we begin this new year 2014 we look to new beginnings as we always do, but Christ comes into the world so that every day might be precious, regardless of the timeline we have created for ourselves. It seems to me that the encounters I have mentioned above are great examples of God working in the ordinary to create something extraordinary. So don't look too far ahead or you might miss something wonderful today. God is always working.

#### Women's World Day of Prayer Friday 7th March An important date for your diary

"Streams in the Desert" is the theme of the service this year, which has been prepared by Christian women of

**Egypt**, and reflects on the Christian role to be streams for those who experience spiritual drought. Our local service will be held on **Friday 7th March at St. Mary's**, **Fetcham at 10.30am** 

Originally written at a time of hope, just after the "Arab Spring", sadly the current political situation means that Egypt remains locked in a protracted process of political transition, deeply divided between Islamist and secular groups, while the military remains the country's chief political broker and decision-maker. Uncertainty and anxiety over the future have generated ongoing political protest, strikes, deep mistrust between Islamist and secular parties, and Muslim-Christian tension and violence. The military has installed an interim government that will lead the process of drafting a new constitution and preparing for fresh elections, which are expected in early 2014, but the situation is highly unpredictable.

Political change affects individual lives and we should all pray with the women of Egypt for peace in their country and throughout the Middle East, where women are being repressed. Just this week a Kuwaiti woman was arrested in Saudi Arabia for driving her diabetic father to hospital. Kuwaiti women are free to drive in their country and enjoy far more rights than those in Saudi Arabia, where women are not allowed to drive, travel abroad, open a bank account or work without permission from a male relative.

Here in the UK respected journalist Yasmin Alibhai-Brown has condemned a recent decision by universities to publish guidelines on gender segregation and sexist dress codes for lectures and meetings as "Shameful concessions to religious bigots".

God please help inter-faith groups to work for the good of all communities.

#### Action Week 2014: Standing alongside people in crisis

"Speak up for the rights of all who are destitute". There are people who are destitute in today's Britain. The phenomenal growth of foodbanks has happened because thousands of people have recognised something needs to be in place to fill gaps left by our creaking benefits system. Without them, families are starving. Low wages, zero-hours contracts, outrageous interest charges by doorstep lenders, benefits cuts, benefits delays, 'sanctions' on job-seekers – all these and more contribute to a Britain where many are locked out of what the rest take for granted.

And there are plenty who are not destitute, but teetering on the edge. "Just two pay-packets away from homelessness" is how many feel.

So from Homelessness Sunday on 26th January to Poverty Action Sunday on 2nd February, we call on Churches across the UK to stand alongside people in crisis; to give, act and pray for justice.

Effingham Chapel is celebrating its 160th anniversary this year, but the Effingham Methodist Society began ten years earlier in 1844.

This is also when the Dorking & Horsham Circuit was first formed.

Could YOU help discover Methodist roots in this area?

Effingham have been taking part in the Heritage Open Days weekend in

September since 2009. Leatherhead and Dorking have been involved for many more years, but the Horsham area doesn't have support from the local council. Could we do something together for 2014 to celebrate our 170th Circuit Anniversary?

An interesting article written by **Rev. John Telford** for the **Methodist Recorder** in 1903 says that the Effingham congregation originally met on the common, where they were occasionally pelted with stones and rotten vegetables by local "ruffians". This seems to be the spark that led **Rev. Aaron Langley** to seek permission to worship in a local house, the home of **Mrs. Mary Cook**.

Several Churches in our Circuit have written histories/guide-books about their Churches and I would like to form a working party to research our early history for an exhibition for each Church during Heritage Open Days weekend from 11th to 14th September 2014.

### CHRIST CHURCH URC AND LEATHERHEAD METHODIST CHURCHES Summary of Options Study Presentation

The Options Study was first presented on 12th December 2013 and is very briefly summarised as follows:

Early sections set out the demographics in order to provide a statistical background not just for the immediate South Leatherhead Ward, but also to the surrounding areas from which the two Churches draw their congregations and provides a valuable framework when assessing future ministry options.

It also set out the constraints likely to be applied to any development proposals and analyses the planning framework in some detail. The Methodist Church is located within the Town Centre Conservation Area and consequently will be subject to even more controls and demolition would not be permitted.

The brief is clearly set out, together with the results of the briefing meetings with individuals.

It also highlights denominational issues and addresses the levy on any sale of land or buildings which will be applied and encourages early consultation to be made with the relevant bodies.

All of the available sites were identified and eliminated for various reasons apart from the long term strategy for the Barnett Wood Lane allotments which it addresses in detail.

The report suggests detailed possibilities for both the Christ Church URC and Leatherhead Methodist Church sites with a number of options proposed. For the URC site, it highlights the land value occupied by the two tennis courts which cover approximately 16% of the total site and questions the future of the present manse.

It shows how redevelopment options for 3-bed semi detached and terraced properties could provide enabling funding for two different proposals, both of which would bring the Church building closer to Epsom Road and reduce the existing linear form of the Church, providing accommodation more fitting for its purpose which is open and accessible to all. One solution of which involves a new worship space with a two storey conversion of the existing Church and the other a completely new building solution.

It also addresses the Methodist Church site and shows how, with relatively modest extensions within the constraints of the Conservation Area, the building could be better adapted to fulfil the brief and suggested that if the existing manse were to be demolished, parking for a minimum of 18 cars could be accommodated on the site some of which on reinforced grass which could then double as a secure play area.

It analyses the likely income and expenditure on a comparative basis while noting the likely levies to be applied by the Holding Trustees to any income received and made suggestions where any surplus could be applied to invest in new ministries in the more needy north Leatherhead Ward or the possibility of acquiring a town centre shop for a drop-in, coffee or third world/ Fair Trade shop.

Finally it shows a series of steps with any consequent costs in order to move forward, once a decision has been made on the kind of solution proposed. It also leaves the door open for the evaluation of any future sites which may become available which would be carried out as a continuing part of the study within the overall costs agreed.

# What did Jesus mean when He instructed us hate our father and mother (Luke 14:26)?

**Answer:** First, we must take this verse in the context of the chapter. Jesus is teaching His disciples, and like any good teacher, He begins with a truth statement that is hard to understand in order to get His students thinking. Then, He clarifies the difficult truth statement with a metaphor. The truth statement is the confusing verse 26, "If anyone comes to me and does not hate his father and mother, his wife and children, his brothers and sisters - yes, even his own life - he cannot be my disciple." So, if we don't hate our family and our own lives, we can't be His disciple. But does He mean we are to have real hatred for our parents?

Next, Jesus relates a metaphor about a man who builds a house without counting the cost and finds that he cannot follow through with what he set out to do. He leaves the house unfinished because he cannot pay what is required. Jesus is showing us the explanation to His difficult statement - that we must count the cost of discipleship. This is the point of the passage. In order to be a disciple, we must be willing to give up everything for Jesus.

Therefore, if our parents will not follow Jesus, or even if they disown us for being Christians, we must still choose Him over them. It is in this sense that we are "hating" our family members who reject the Lord or reject us because of the Lord. This is not easy, and of course it is right that we should love our family members and want our family members to love and follow God. After all, 1 John 4:7-8 says "Beloved, let us love one another for love is from God and everyone that loves is born of God and knows God. The one who does not love does not know God for God is love." And that is only one of many passages commanding us to love others. But despite our love for the people we know, here is the key: if they don't love Jesus, He must still be our first priority. We must esteem Him more highly than the people we love here on earth and we must love Him more than our own lives. In fact, we must love Him so much that our earthly loves pale in comparison, even to the point of seeming like hate.

Second, let's take it in context of other places in the Bible. *Matthew 19:29* says, "And everyone who has left houses or brothers or sisters or father or mother or children or fields for my sake will receive a hundred times as much and will inherit eternal life."

So, here is the promise: God has required total commitment from His followers, to the point of heart-breaking separation from any natural family members who reject Jesus, but in heaven we will have a hundred times what we lost - an entire family of believers who love Christ and who love us! Even the material things that we had forsaken in order to follow Him will be given back to us in a form a hundred times better than what we lost! So, He is a good God, after all, and, no, He does not want us to literally hate (viciously despise or wish harm to) the members of our family. All we are required to do is choose Jesus over them even if they force us to do so by rejecting Him.

Jesus may have chosen the word "hate" to show us that this is how a mother or father will perceive the actions of a child who chooses the Lord above them. They will see it as disloyal, especially if we try to witness to them. The love of a Christian for a non-Christian is almost always seen as hatred, intolerance, bigotry, etc. But we must be okay with being seen as "hating." After all, our unbelieving relatives are part of the world, and Jesus said, ""If the world hates you, keep in mind that it hated me first" (John 15:18)


